

Living in Sonoma Valley we know just how fortunate we are. Just 40 miles north of the Golden Gate Bridge, the region provides the "perfect blend" of a friendly, small-town, wine-country community with a rich history and access to exceptional parks, local food, art, and cultural activities. No wonder so many choose to retire here.

Life in Sonoma Valley is dreamy for many but it is anything but for the growing number of local seniors that are struggling to make ends meet and are living on a fixed income, relying on meager savings, social security, and government assistance programs.

According to www.bestplaces.net, 25% of the population of the Sonoma Valley

is age 65+ and that number jumps to 38% in the city of Sonoma. Living in a region where the overall cost of living is anywhere from 131% to 530% of the national average, it begs the question, "how do local seniors living on a fixed income get by?"

As reported in our Spring/Summer 2019 issue of The Vintage Voice, our Impact 100 funded research study confirmed what we already suspected. A growing number of Sonoma Valley seniors need access to more services in order to make ends meet. Vintage House has launched new and innovative partnerships to address the two leading factors-income and

# The Halls are Alive!

Long shadows grace our parking lot, with chilly morning air and warm afternoon breezes whisking people into our lobby. Friends gather around the front desk and grab a cup of coffee. Lively conversations get underway as people head off to one of our many classes or activities. Our hallway arches are decorated with colorful and playful masks made by a local artist. The halls are alive at Vintage House— alive with fresh offerings for older adults of all ages, made possible by our innovative partnerships with a myriad of organizations and accomplished professionals who want to share their wisdom and talents.

Are you interested in health and wellness? Then keep a lookout for another three-part series titled Planning Ahead, designed by Sonoma Valley Hospital that will cover the topic of navigating change, including financial and legal issues, and hospice. Have some bad habits you would like to kick? There will be a health and wellness panel that will get you on the road to breaking them. For those who have been wanting a morning meditation class, we have added this to our schedule and now offer meditation classes in the morning and evening.

Do you need some support? Safe driving classes, support groups, and tax assistance will continue, and we have added new services we would like to highlight. Vintage House has partnered with the Alzheimer's Association, Sonoma Valley Hospital, and a new, local grassroots group called Care Partners Initiative to bring more resources and support to Sonoma Valley caregivers of those living with memory loss. The partnership presented an all-day seminar on October 5th at Vintage House with more than 85 in attendance. We learned that there is a tremendous need for caregiver support here in the Valley, and this demand will only grow as our senior population continually increases.

Perhaps a new class isn't what you're looking for but you would like to have a comfortable place to hang out and meet other people? You can do that here at Vintage House. You can also come and learn how to play Mah Jong! Do you enjoy sharing a meal with others? In addition to Soup's On! each Friday at Vintage House, we will be offering a



housing affordability—impacting the ability for many seniors to age in place in the Valley of the Moon.


Vintage House is helping Seniors in need of extra income find work through JobConnect. A growing number of Sonoma Valley seniors are struggling to make ends meet. For some, they must choose between paying their rent, mortgage, or utilities and buying food or prescription medications. Increasingly local seniors are seeking part-time employment to supplement their income but many have no idea how to begin to look for work. That's why we launched JobConnect.

Vintage House is teaming up with local employers that have part-time positions available and who are interested in employing local seniors. Through JobConnect, Vintage House is screening interested candidates for open positions and connecting qualified individuals with local employers. JobConnect helps seniors, employers, and our entire community.

Connecting Seniors with Housing Resources: Vintage House is teaming up with SHARE Sonoma County (Shared Housing and Resource Exchange), a program that works to provide affordable, attainable housing so that local seniors can "age in place." What many don't realize is that a growing

number of seniors are being pushed out of their homes due to rising rents, and others who may own homes can no longer afford to meet the ongoing costs of maintaining them.

SHARE facilitates secure home sharing situations for homeowners and renters who are currently stressed financially, experiencing life transitions, looking for companionship, or needing basic assistance (which can be a service exchange) to help them thrive and remain safely at home.

Vintage House is providing office space for the local SHARE Housing Coordinator on the second and fourth Friday of each month. # Your Legacy. Our Future.

As a Vintage House member and supporter, you have demonstrated your commitment to providing for the needs of older adults in the Valley of the Moon and you've helped us to assist seniors at every life stage to enjoy a better quality of life as they age in place in the community.

Whether you are still working or are retired, planned giving can benefit you and your loved ones while helping to ensure that the organizations you care about most will continue to benefit from your support for generations to come.

There are many types of planned gifts—certain gift types have an impact now, while others benefit the recipient after your lifetime.

# What are the 3 basic types of planned gifts?

- First, outright gifts that use appreciated assets as a substitute for cash;
- Second, gifts that return income or other financial benefits to the donor in return for the contribution such as charitable annuities and charitable remainder trusts:
- Third, gifts payable upon the donor's passing.

# What are the tax benefits of planned gifts?

- Donors can contribute appreciated property, like securities or real estate, receive a charitable deduction for the full market value of the asset, and pay no capital gains tax on the transfer.
- Donors who establish a life-income gift receive a tax deduction for the full, fair market value of the assets contributed, minus the present value of the income interest retained; if they fund their gift with appreciated property they pay no upfront capital gains tax on the transfer.
- Gifts payable to charity upon the donor's death, like a bequest or a beneficiary designation in a life insurance policy or retirement account, do not generate a lifetime income tax deduction for the donor, but they are exempt from estate tax.

Regardless of the size of your estate, you can make a lasting impact here in Sonoma Valley and a lasting impact for Vintage House and the growing number of older adults who count on us year after year by making a legacy gift.
